The Bond will be returned to my/our nominated bank account at the end of the season, after confirmation by the Roster Manager and/or Chairperson that duties have been satisfactorily fulfilled.
3. In the unavoidable event that I/we cannot attend an allocated duty then I/we acknowledge that it is my/our responsibility to find a suitable replacement.

Training/Competitions

4. The Club insists parents (or guardians) be present at all competition meets and at training. The Club does not accept liability for injury or care of athletes and **it is the parent's responsibility to ensure that arrangements are made for the supervision and care of their child/(ren) during training and competition.** By registering your child/(ren) to compete you acknowledge and agree that the Club will not be liable for any injury to your child/(ren) that may occur during any event conducted by the Club. Whilst it is not a common occurrence, as in all sports, players do run the risk of injury. The Club



carries **NO** personal accident insurance cover. In the unlikely event of your child being injured it is essential that you have adequate medical or accident insurance.
